

What went really well about this course?


- 1. Most of the content was also repetitive, that should be avoided. The structures of the debates should also be improved.
- 2. idk
- 3. The slides describing the papers in the first part of the course could have a bit more information on e.g. the interpretation of certain figures/tables. Obviously one can look into the papers themselves however I doubt that most of the students do. Additionally the debates and the paper were not really demanding and seemed more like a filler, which begs the question, were they even necessary?
- 4. I feel there was a lack of structure in the course, It felt like it was the combination of a bunch of seperate topics, quickly looked at to determine the incentive structures. A synthesis with more of a combination of all topics, showing for instance its hard for governments to get everything perfect without gaining a bunch of debt would be a nice addition. For the political economy part. It felt too theoretic, an analysis of the results of certain voting systems through their quirks and looking at case studies would make this much more engaging
- 5. The second part could be switched with the first part to make the course flow a bit better as it did not make sense to all of a sudden have a transition from empirics to so many models. Further the debates could be structured clearer (specify enrollement for specific tutorial groups etc) and with an extra challenge as it felt like a first year assignment and not a second year.
- 6. I believe the debate format was not well executed. There was no actual possibility for debate and no audience interaction.
- 7. The debate scheduling was very poor. I grant you that it was not entirely your fault as the students to figure it out for themselves it would have been better to (randomly) assign groups to certain times, and publish this schedule on canvas.

 Another minor issue is the quality of figures included in the lecture slides by David. I understand poor quality if it is from an older article, but even from screenshots from relatively recent articles, the quality was very poor.
- 8. Everything. This course needs a serious restructuring. Lectures, tutorials have nothing to do with the exam, and it is not even clear which papers are covered for the exam!
- 9. No clear information about the exam. The first part had too many papers per lecture, it was overwhelming. There was a weird schedule in the last 2-3 weeks when the tutorial for the week was before the lecture and it was super confusing, maybe next time take the initiative to fix the problem.




The explanations of the lecturer were clear to me.


The lecturer stimulated me to think actively about the subject matter.
